ugust 26, 2020 marked the 100th Anniversary of the adoption of the 19th Amendment to the U.S. Constitution. The amendment states: "The right of citizens of the United States to vote shall not be denied or abridged by the United States or by any state on account of sex. Congress shall have power to enforce this article by appropriate legislation."

From the Women's Rights Convention at Seneca Falls, NY in 1848 to the historic action in 1920, our ancestors fought a hard-won battle, 72+ years long. They knew once voting rights were secured, other concerns could be addressed, such as rights to: custody of children in a divorce; own and inherit property; sign contracts and even serve on juries – not that special today, but the "jury of your peers" was all men at the time.

### TIMELINE | THE MARCH TO THE VOTE

**1848** | Convention on Women's Rights in Seneca Falls, NY. The "Declaration of Sentiments," a manifesto calling for equality, was passed.

**1869** | Elizabeth Cady Stanton and Susan B. Anthony form the National Woman Suffrage Association (NWSA). They seek a federal constitutional amendment for suffrage.

**1869** | Abolitionists Lucy Stone (a clubwoman) and Henry Blackwell found the American Woman Suffrage Association (AWSA). They sought to amend state constitutions to acquire the vote.

**1878** | Congress forms committees to study and debate the issue. The proposal reached the Senate floor in 1886, where it was defeated.

**1890** NWSA and the AWSA merged to form the National American Woman Suffrage Association (NAWSA). The new organization lobbied stateby-state. In 1900, clubwoman Carrie Chapman Catt stepped up to lead the NASWA.

**1913** | Illinois was the first state east of the Mississippi to give women limited voting rights.<sup>1</sup>

#### **GFWC INVOLVEMENT IN SUFFRAGE**

It is difficult to take an organization-wide stand on issues when members have deep and varying opinions (think gun control). This was true of suffrage. Illinois' own Ellen Henrotin said in a speech as newly elected President of GFWC in 1894: "Other organizations of women represent each a single cause; the federation represents the sum and the soul of all causes."2 Yet, Eva Perry Moore, GFWC President from 1908-1912, spoke at the 1906 convention of NAWSA along with Susan B. Anthony. Eva's successor, Anna Pennybacker, was a prominent women's suffrage advocate. It's been said that GFWC's endorsement of suffrage was "gradual and nuanced."3

"I never doubted that equal rights was the right direction. Most reforms, most problems are complicated. But to me there is nothing complicated about ordinary equality." — Alice Paul

At GFWC Convention in 1912, a Resolution was proposed in support of women's suffrage. The resolution was deemed "out of order." Many clubwomen supported the cause and numerous State Federations had already endorsed the proposed amendment, yet GFWC as a whole was not ready to publically support the issue.

In this incredibly progressive era, clubwomen began to adopt more civic-minded causes. Clubwomen saw it as their duty to support children, newly arrived immigrants, literacy, the arts, the environment, and more. Support for suffrage began to grow.

In 1913, clubwomen marched in the massive women's suffrage parade in Washington, D.C. The event was a turning point and shifted sentiment within GFWC.

On the day of the parade, thousands of women estimates vary between 5,000 and 10,000—massed at the Capitol. At the front of the parade was Inez Milholland, a pioneering suffragist who led the parade from atop a white horse. Milholland's beauty played against stereotypes of suffragists as dour spinsters. She was the perfect figurehead for the parade. Held the day before Woodrow Wilson's Inaugural, the march occupied much of the town, making Wilson's arrival in DC that day less boisterous than he expected.

At the 1914 Biennial in Chicago, the resolution to endorse suffrage was again raised. Voting was now understood as an extension of club work. With WWI looming, voting also became an urgent matter of patriotic duty. In an address to the clubwomen at this convention, Carrie Chapman Catt assured the women that voting was their highest moral and patriotic duty.

On June 13, 1914, GFWC passed a resolution endorsing "political equality of men and women" and the right of women to vote!

#### (NEARLY) FINAL MEASURES

The momentum for suffrage continued to build. The proposed amendment passed the U.S. House on May 21, 1919 and the U.S. Senate on June 4, 1919. Thirty-six states were needed for ratification. Wisconsin, Illinois and Michigan were the first (Great Lakes Pride!). Within a year, 35 states ratified the amendment. One more was needed.

This wasn't promising. Seven southern states had already rejected the measure and Tennessee had landed at 48-48 until 23-year-old Representative Henry T. Burn stepped up to vote. He was personally opposed to suffrage. Luckily, his mother (a clubwoman) was more sensible and she had sent him a note: "Don't forget to be a good boy and help Mrs. Catt." He listened to his mother and the rest is herstory!

The vote was cast on August 18, 1920, but ratification was certified by the U.S. Secretary of State on August 26th, making it official.



Help us to win the vote

That November, more than 8 million women voted for the first time. It took 64 years for the remaining 12 states to ratify the 19th Amendment.

Enforcement of voting rights for ALL women lagged behind. For Native American women, rights were enforced in 1924, Chinese American women in 1943, Japanese American women in 1952 and African American women were not fully enfranchised until the Voting Rights Act of 1965.

Throughout the long and difficult struggle for their own civil rights, suffragists were satirized, laughed at, divided, attacked, libeled, lied to and callously dismissed. That they persevered without violence is a testament to their enduring strength and faith. We are truly grateful!



WINGS is the largest provider of domestic violence services, programs and housing in the state of Illinois. When WINGS clients leave a shelter for a safe permanent home, they pass a wall filled with handpainted 'Encouragement Boards.' They take one of these lovingly made pieces of art with them to their new home.

In October 2019, led by Therese Fuglaar, Chairman of GFWC Northwest Suburban Woman's Club's Domestic Violence Awareness & Prevention Committee, 17 members armed with paintbrushes and a "we're here to paint our hearts into this' attitude gathered to paint and letter fifty 8-1/2 x 11" 'Encouragement Boards.'

Therese, who organized and led this project, also has a reputation for thriftiness.

The club donated \$50 to this project, which she stretched with the 40%-off craft store coupons she clipped every week for six weeks, to buy canvas, paint and stencils. Club members also made donations of table coverings, brushes and other art supplies.

WINGS gave Northwest Suburban a room at one of their storage facilities to do this project. The WINGS Volunteer Coordinator and one of the WINGS Shelter Managers came during the painting session to thank the Club and talk about all of the good that WINGS does in the community.



s you have heard through newsletters and ZOOM calls, GFWC Illinois is embarking on a historical journey to reshape our organization and realign geographically. We are looking to the future to preserve our legacy of volunteer service and embrace our diversity of age, experience, and interests.

We are a much smaller organization than 25 years ago and have seen an 82% decline in membership. In addition, our annual income has been reduced from \$100,000 to \$32,000. With everyone's help and enthusiasm, we will become a stronger organization and overcome any challenges we may encounter as we progress through this journey. It is an exciting time to be a member of GFWC Illinois!

The benefits of the proposed organization are many.

- More streamlined Executive Committee and Board of Directors
- Addresses the desire for districts to combine
- Creates a larger leadership pool with a new mix of clubs in the Regions
- Focuses region leadership on club engagement and leadership development without district overhead

Our organization (as depicted at right) will be structured with one Executive Committee and one Board of Directors, supported by region leadership for all clubs with Region Presidents and Region Directors of Junior Clubs. We have eliminated the district structure to stem the tide of recycled leaders and in response to the diminished value of districts as seen through low club participation.

Over the last 25 years, we have lost 6 Districts and 10 Junior Districts with 96 associated clubs. The proposed geographic realignment (as shown on next page) has six regions throughout the state, each similar in size by the number of clubs. Apart from the North Metro Region, they are equal in size by # of members.



## HOW TO HOST AN EFFECTIVE ZOOM MEETING

ou've chosen your virtual meeting platform, you have your meeting date set and you've sent your meeting invitation out. Where do you go from here? I'm sure many of us are asking this question as we start the year out with virtual meetings. Here are a few tips



and reminders you should keep in mind as you conduct your ZOOM meeting.

- AGENDA: Make sure you send out your agenda prior to the meeting date. Sending your agenda out early will enable your members to review what will be covered in the meeting beforehand. You may also need to follow up with your presenters to make sure they have what they need for the meeting.
- MATERIAL: Simplify your meeting material as much as possible. Your audience will typically be a little less attentive at a virtual meeting, meaning the longer your meeting goes on, the less attentive they will become. If you have chairmen reporting, have them simplify their reports as much as possible during the actual meeting. You can always send out more detailed chairmen reports along with your agenda.
- SOCIAL TIME: Remember to leave time in your agenda for socializing, as this is still an important element for your club and members. You don't want members leaving the meeting feeling gypped out of telling their friends about something exciting in their life. Allow at least 15–20 minutes either before the meeting starts or after it is over for members to chitchat.
- HOST: In addition to sending out your agenda prior to the meeting date, delegate a host for your meeting. If you have a lot of members in attendance, delegate a few co-hosts. Hosts help answer member's questions about accessing the meeting, admit members into the meeting and also make sure members' microphones are on mute as they come into the meeting. Hosts can also help facilitate ZOOM's "Chat" feature during the meeting. You will want to encourage your members to use the "Chat" feature to talk socially and to ask any questions regarding the meeting content. Your host or co-hosts could be the members that serve on the club's Hospitality Committee.
- ROBERT'S RULES OF ORDER: Your actual meeting will be conducted the same virtually as it would be if you were meeting in person. This means that you should adhere to Robert's Rules of Order just as you would at a "live" meeting. The President of the club will call the meeting to order and the meeting will get underway following the meeting's Agenda. Make sure you follow Robert's Rules of Order throughout the entire meeting. This is very important as you do not want to lose control of the meeting.

- PLEDGE OF ALLEGIANCE: There have been some questions on how to recite the Pledge of Allegiance during a virtual meeting. You may want to delegate one person to recite it and then those attending the meeting can recite it at home on their own. Make sure the person reciting has a flag they can hold. You may also use a video clip of the Pledge of Allegiance for all to watch and recite on their own. This could be fun if you delegate someone from your club to recite the Pledge of Allegiance and they send in a video of them doing so.
- CLUB COLLECT/JUNIOR PLEDGE: As mentioned above about the Pledge of Allegiance, the same ideas can be used to recite the Club Collect and/or the Junior Pledge.
- MAKE IT FUN: Have fun with your meeting and switch up what you are presenting so you don't lose your audience's interest. Maybe have a fun theme for the meeting and include an ice breaker that can be done virtually. This will help you keep your members engaged during the meeting.

# FOCUS ON MEMBER ENGAGEMENT

embership is the key to any organization. Members put in the time and energy necessary for success. They are the heart of every organization. Volunteer organizations such as ours depend on dedicated members and supporters to thrive. Membership retention begins the second a member joins the Club! One of the biggest factors in retention is member engagement. Now more than ever, we need to maintain our current members and recruit new members by making them feel welcome and offering plenty of opportunities to get involved. Fortunately, there are many different techniques to accomplish that!

- **Monthly newsletters or flyers** are a great way to keep the membership informed and engaged. Consider holding a ZOOM or Microsoft Teams virtual meeting.
- Email is a great form of communication. Send an email blast out to the membership letting them know the Club is thinking about them. For those members not so technically savvy, a good old-fashioned handwritten note or a phone call can really brighten someone's day and in this digital age is so much more memorable and meaningful.
- Motivate your members by organizing a club project or **virtual fundraiser** to keep them engaged and connected. Use social media to promote your Club and keep it up to date with current events and meeting information. Ask members to share club activities on their social media pages.
- **Be inventive.** Hold your board or club meeting outdoors. Assign a theme to the meeting to make it more fun and get members involved. Have a short musical performance to draw attendance.
- Encourage members to reach out and promote membership in your GFWC Club. Some people just need to be asked to join and may turn out to be your best club "go-getter" and motivator. Ask members to share your club newsletter, "like" your Facebook page or to bring a friend to meetings.

- **Recruit new members.** Create a Club brochure that includes a membership application and place them around town at City Hall, the Library or Recreation Center. Reach out to past members. Send a "win-back" email, letter or phone call to lapsed members. Ask for feedback as to reasons they left to reduce membership turnover. Does your town have a Farmer's Market? Set up a table with an eye-catching poster or banner advertising your Club and target the women shoppers.
- Smile and say thank you. Nothing is more welcoming than a bright smile or more rewarding than being thanked. After a successful project, consider creating a video 'thank you' from your President and board with highlights explaining why the event was successful; then post it on social media or the Club website.
- **Have fun!** Volunteering and helping your community is rewarding and fulfilling. Belonging to a club promotes socializing, builds bonds and forms long term friendships. Research shows that people who volunteer over 100 hours a year are some of the healthiest people in the U.S. Purpose and collaboration results in mental health improvements and a better outlook on life.
- **Initiate government involvement and support.** Set up a meet and greet with your Mayor and City Councilmen. Invite them to attend special club events as guests. Ask your Mayor to speak at a Club meeting. Request to be put on the Agenda to speak at a City Council meeting to promote your club and special events. Join the Chamber of Commerce and appoint a club delegate to attend meetings to promote membership.
- Promote your club and events. Announce meetings and events in your local paper with an open invitation to attend. If your town has a local TV station, contact the producer and arrange for a live interview to promote your Club membership or fundraiser events.

In keeping with our President's motto... Let's not talk about it. Let's Bee about it! So keep those hives buzzing this fall and try one or more of the techniques mentioned above to engage and connect with current members and recruit new ones.

psilon Sigma Omicron (ESO) is an honorary educational society open to all per-capita paying GFWC federated club members. Many GFWC clubwomen have profited from this unique self-improvement program. ESO can take the form of a club reading group or an individual's personal reading pursuit. It has helped many members learn to read out of their comfort zone and explore new subjects that would have passed them by!

To become a member, you only must read! There are many levels of participation and recognition available!

The basic structure of the organization is:

- Pledge Welcome to ESO!
- **Member** Has read 16 books (4 sets of 4 books) A Member is eligible to purchase the GFWC ESO pin from the GFWC website when she reaches the Member level.
- Star Has read 40 books (an additional 6 sets of 4 books)
- Torch Has read 64 books (an additional 6 sets of 4 books)
- **Century** Has read 100 books (9 additional sets of 4 books)
- **2nd Century and Beyond** Members may continue to read and reach additional Century levels for each 100 books read.

**NEW THIS ADMINISTRATION!** After reaching the 2nd Century level, readers will only be required to report the author, book, category and hours spent reading. (Though I will admit, your ESO Chairman will miss hearing your thoughts on each of your books!)

**NOTE!** In the past, ESO has required us to read in sets of 5 books. The national organization is transitioning to sets of 4. We will accept either sets of 4 or 5 this year, but hope to have all our Illinois readers reporting in the smaller grouping of 4 books by the end of 2021.

And what about the types of categories our members are using for their sets of books? In addition to obvious choices such as Biography, Fiction: Mystery, Fiction: General, and Self-Improvement, Illinois readers have created a number of unique categories that cater to a variety of interests. Some examples include: Civil War, Scary Stories, Women's Studies, The Amish, The Wild West, Christmas Stories, Books by the Same Author, Books by Illinois Authors...well, you get the picture. The sky is pretty much the limit!

The ESO program provides certificates, pins, reading lists, and suggested categories on the GFWC web page, including a framework in which to pursue continued self-improvement through reading. Many clubs organize a members' book club, invite authors to visit meetings and promote local literacy programs and library activities. Because really... who doesn't LOVE to read?

### MACOMB WOMAN'S CLUB CENTENNIAL CELEBRATION OF THE 19th AMENDMENT
