CALL TO CONVENTION 2021


GFWC Illinois Federation of Women's Club Bylaws Article VII, CONVENTIONS Section 1. Annual Convention

GFWC Illinois shall hold an annual convention in May. The Call to Convention and proposed Bylaw Amendments, Resolutions and Revisions shall be sent to the voting body of GFWC Illinois by the Headquarters Executive Secretary or included in the Convention issue of the "GFWC Illinois Clubwoman" six weeks before the Annual Convention.

After much consideration, due to the continuing concern related to COVID-19 and current state restrictions, as well as the safety of our members, the GFWC Annual Illinois Convention Business Session will be held virtually on May 1st via Zoom. The GFWC Illinois Annual Convention is open to all members. Per our normal practice, a \$25 registration fee will be required. The registration fee covers the cost of both Friday/Saturday participation and attendance. (A side note: Virtual meetings via Zoom are not free to our organization.)

Each registered member is entitled to vote, and, this year, there are proposed

bylaws amendments requiring member approval. We will be focusing on just the Tier I Bylaws at this time. If you choose to attend the Zoom meeting in a group, only the member logged into the Zoom meeting will be counted for voting purposes.

CONVENTION 2021 | GFWC ILLINOIS PROPOSED BYLAW AMENDMENTS | TIER 1

As recommended by the Bylaws Committee

Chairman Jeanette T. Wells, Central Region Vice President Cathy Marsoun, District President Susan Haa, President Elect LeeAnn Conlon, Director of Junior Clubs Patti Kuchar, Parliamentarian Diane Addante and President Teresa Sanford-Shipplett, ex-officio

Note: In order to conduct the business of GFWC Illinois under extenuating circumstances, the following bylaw is presented for your consideration to allow for electronic or virtual meetings and voting capabilities. These proposed amendments will be presented for consideration at our 2021 Annual Convention.

Add Article XIII as follows: ARTICLE XIII—DECLARED EMERGENCY/DISASTER

Section 1. In the event an Emergency/Disaster is declared affecting the viability of holding a meeting, the GFWC Illinois President, with consent of the Executive Committee, may authorize all meetings, including Executive Committee, Board of Directors, and/or Annual Conventions, to be conducted through use of virtual meeting services.

Section 2. Meetings Held Virtually

- A. The virtual meeting service shall be selected by the Executive Committee.
- B. Such meetings should allow full-featured virtual meeting services that integrate audio, video, text, and voting capabilities.
- C. Procedures for conducting virtual meetings shall be established by the Executive Committee.
- D. A vote conducted through the virtual meeting service shall be considered a ballot vote, fulfilling any requirement set forth in these bylaws that a vote be conducted by ballot.

Section 3. Board of Directors. In the absence of an in-person Board of Directors meeting, any business may be approved electronically in accordance with procedures approved by the GFWC Illinois Executive Committee. Members shall be required to register for a remote Board of Directors meeting.

Section 4. Virtual Annual Convention. In the absence of an inperson Annual Convention, a virtual Annual Convention may be held. This convention may be pre-recorded, whole or in part, or held with members attending remotely while it is in session.

- Registration: Registration shall be required for members to participate in discussion and voting at any virtual convention.
- Voting: See Article VII of these bylaws for the voting body. The Credentials Committee Chairman shall verify the voting members.
- C. Pre-recorded virtual Annual Convention: The GFWC Illinois Executive Committee shall establish a timeline to provide registered members with proposed bylaws amendments, resolutions, endorsed candidates' resumes and ballots. The voting body shall be those who have registered.
- Virtual Annual Convention (Real Time): The sessions of this type of Annual Convention shall be conducted through use of virtual remote meeting services designated by the Executive Committee. These services shall:
 - 1. Support anonymous voting;
 - 2. Support identifying information of those participating;
 - 3. Identify those seeking recognition from the chair for permission to speak;
 - 4. Display the text of pending motions; and
 - 5. Display the results of votes.

RATIONALE: Authorizes the use of virtual meetings during a declared emergency/disaster.

Note: These proposed amendments were printed in the 2020 Convention Issue of *The Clubwoman* magazine; however, they were not voted on due to the cancellation of the 2020 Annual Convention. They will be presented for consideration at our 2021 Annual Convention.

ARTICLE V-OFFICERS, Section 2. CANDIDACY,

A. Eligibility, 2.b.

Strike "as an officer of", "GFWC Illinois", and "Organization" and inserting "Board" after "Organization".

To Read: b. Have served an additional two years as a voting member of the Board of Directors or Junior Board.

Rationale: More eligibility for both Boards.

ARTICLE V—OFFICERS, Section 4. VACANCY

Insert a new D.

To Read: D. An officer may be removed from office with cause by a two-thirds vote of the Board of Directors.

Rationale: This is not currently addressed in the bylaws and aligns with GFWC bylaws.

ARTICLE VII—CONVENTIONS, Section 1. ANNUAL CONVENTION

Strike "May" and insert "the spring" in the first sentence.

To Read: GFWC Illinois shall hold an annual convention in the spring.

Rationale: Allows more flexibility in scheduling.

ARTICLE VII—CONVENTIONS, Section 2. REPRESENTATION, A.

In 1., Delete "Club Delegates" and "may attend Convention as a delegate", Delete 2., 3., and 4., renumber 5. and 6.

To Read: A. The voting body of the GFWC Illinois shall consist of:

- 1. Any member in good standing.
- 2. GFWC Illinois Past Presidents.
- 3. GFWC Illinois Past Directors of Junior Clubs.

Rationale: All members in good standing who attend convention



Note: These proposed amendments will be presented for consideration at our 2021 Annual Convention as recommended by the 2020–2022 Bylaws Committee.

Article XI—AMENDMENTS, Section 1. AMENDING PROCEDURE, Subsection B. and C.

Insert a new B.

To Read: B. Bylaws may be amended at any statewide meeting by two-thirds vote of those present and voting, providing that notice of the proposed amendment has been sent to the GFWC Illinois voting body 30 days prior to the meeting.

B. becomes the new C.

Rationale: To allow for an additional opportunity to propose and vote on needed amendments.

Article V—OFFICERS, Section 3. Elections, Subsection B., Items 5. and 6.

Delete B.5. In its entirety and replace.

To Read: 5. If there are contested races, all candidates will be elected by ballot. A plurality vote shall elect. If there are not contested races, the election may be by voice vote.

Rationale: To clarify.

Add a new 6.

To Read: 6. In the event an emergency forces the cancellation of a convention in an election year, contested races will be determined by electronic ballot. The voting body will consist of the voting members of the board of directors and club presidents. If there are no contested races, the candidates will be elected by acclamation. Their term will begin when the convention was scheduled to end.

Rationale: To address the process of the election if convention needs to be cancelled.

Article VI—BOARD OF DIRECTORS, Section 5. Duties, Subsection L.

L. Strike "by mail" after "election" and before "in".

To Read: L. Cancel the annual convention and adopt rules for the conduct of the election in an emergency.

Rationale: We would not vote by "snail mail" and this has been addressed elsewhere in the bylaws.

Article VI—BOARD OF DIRECTORS, Section 10 COMMUNITY SERVICE PROGRAM, ADVANCEMENT, STANDING, AND SPECIAL COMMITTEES, Subsection B., Item 1.b.

In the second sentence insert "or electronic" after "voice" and before "vote".

To Read: b. Chairmen and committee members of Community Service Program, Advancement, Standing and Special Committees shall be elected by the Board of Directors no later than the Spring Meeting in the even-numbered years. Election shall be by voice or electronic vote unless there is more than

one nominee for any chairmanship; then election shall be by ballot. A majority vote shall elect.

Rationale: To allow for electronic votes if needed.

Article IV—DUES AND FINANCE, Section 4. FINANCIAL AUTHORIZATION. Subsection A. and B.

A. In the first sentence strike "shall" and insert "may" after "funds" and before "be"; insert "paid" after "be" and before "by".

To Read: A. Disbursement of GFWC Illinois funds may be paid by check which shall bear two signatures. The authorized signatures shall be the Treasurer's and the President's. In the absence of either officer, the President Elect shall be authorized to co-sign checks.

Rationale: Not all disbursements are paid by check.

B. Insert the words "Headquarters Executive Secretary or" after "the" and before "or".

To Read: B. The Board of Directors shall authorize the Headquarters Executive Secretary or accounting firm to pay recurring bills from vendors by check or electronically.

Rationale: The Headquarters Executive Secretary also processes recurring bills electronically.

Article VI—BOARD OF DIRECTORS, Section 2. ELIGIBILITY, Subsection B.

2.B. Strike "concurrently hold more than one position on the GFWC Illinois Board of Directors, the Junior Board of Directors, or on both the GFWC Illinois and the Junior Board of Directors, permitting them only one vote per issue" and insert "hold one position on the GFWC Illinois Board of Directors" after the word "to".

To Read: 2.B. GFWC Illinois members shall be eligible to hold one position on the GFWC Illinois Board of Directors.

Rationale: To allow more opportunities to join the Board of Directors.

Article VI—BOARD OF DIRECTORS, Section 3. TERM, Subsections B., C. and D.

B. Strike "member" and insert "Chairman" after "A" and before "may"; strike "with the exception of Executive Committee Officers" at the end of the sentence.

To Read: B. A Chairman may serve in the same position for a maximum of two consecutive terms.

Strike C. and D. in their entirety.

Rationale: Update to current practice (and the Executive Committee is addressed elsewhere).

Article VII—CONVENTIONS, Section 2. Representation, Subsections B. and C.

B. Strike "Delegates" and insert "Members" at the beginning of the sentence.

To Read: B. Members shall pay registration fees for the entire convention to be entitled to vote.

C. Strike "delegate" and insert "member" after "A" and before

To Read: C. A member shall represent only one club and shall have only one vote at the annual convention.

Rationale: All members in good standing who attend convention and pay registration fees can vote.

Article VII—CONVENTIONS, Section 4. Registration, Subsection A.

A. Strike "delegate" and insert "member" after "every" and before "attending".

To Read: A. A registration fee shall be required of every member attending convention. Registration fees shall be waived for visitors.

Rationale: All members in good standing who attend convention and pay registration fees can vote.

Proviso: The following, if adopted, will be effective at the start of the 2022-2024 Administration.

Article V—OFFICERS, Section 1. OFFICERS

Insert "Director Elect of Junior Clubs" after "Elect" and before "a".

To Read: 1. The GFWC Illinois officers shall be President, Director of Junior Clubs, President Elect, Director Elect of Junior Clubs, a Vice President from each Region, Secretary and Treasurer.

Rationale: Consolidating the Executive Committees

ARTICLE V—OFFICERS, Section 3. ELECTIONS, Subsection A., Item 1.

Insert "Director Elect of Junior Clubs" after "Elect" and before "a"

To Read: 1. The following officers shall be elected in the evennumbered years: President Elect, Director Elect of Junior Clubs, a Vice President from each Region, Secretary and Treasurer.

Rationale: Consolidating the Executive Committees

ARTICLE V—Section 5. DUTIES OF OFFICERS, Subsection B. **Director of Junior Clubs**

B.1. Strike in its entirety and replace as follows:

To Read: B.1. Perform the duties of the President in her absence or at her request.

B.2. Strike in its entirety and replace as follows:

To Read: B.2. Direct the planning of and preside over GFWC Illinois Junior Meetings.

B.3. Strike in its entirety and replace as follows:

To Read: B.3. Lead the Junior Organization to deliver the goals and objectives of GFWC Illinois as guided by the GFWC Illinois Strategic Plan.

B.5. Strike in its entirety and replace as follows:

To Read: B.5. Serve as chairman of the Illinois Junior delegation at the GFWC Annual Convention in the odd year during her administration and the even year following.

B.6. Strike in its entirety and replace as follows:

To Read: B.6. Serve as ex-officio member of all committees, except for Elections Committee.

B.7. Strike in its entirety and replace as follows:

To Read: B.7. Educate Junior Club members on GFWC and GFWC Illinois. Mentor and coach District Directors of Junior Clubs for leadership development and encourage participation in LEADS.

Add a new B.8. as follows:

To Read: B.8. Prepare and conduct orientation and training for the Board of Directors with the President.

Add a new B.9. as follows:

To Read: B.9. Participate in the full financial audit or review held in the Fall each year of the administration. As Immediate Past Director of Junior Clubs participate in the full financial audit in the Fall immediately following her administration.

Add a new B.10. as follows:

To Read: B.10. Oversees fiduciary management of the organization with the President and may co-sign GFWC Illinois checks.

Add a new B.11. as follows:

To Read: B.11. Perform such other duties as may be assigned by the President.

Rationale: Consolidating and updating roles of each Executive Officer

ARTICLE V—Section 5. DUTIES OF OFFICERS, Subsection C. **President Elect**

C.1. Strike "her" and insert "the" after "President" and before "absence"; strike "or at her request" and insert "of both the President and the Director of Junior Clubs" at the end of the sentence.

To Read: C.1. Perform the duties of the President in the absence of both the President and the Director of Junior Clubs.

C.4. Strike in its entirety and replace as follows:

To Read: C.4. Conduct activities to prepare for her administration.

C.7. Strike in its entirety and replace as follows:

To Read: C.7. Coordinate all annual state GFWC Award Entries by GFWC deadlines annually and assist the Reporting Committee and President in compiling the reported statistics of all GFWC Illinois Chairmen.

C.8. Strike in its entirety and replace as follows:

To Read: C.8. Member of the Executive Committee, Strategic Planning Committee, Bylaws Committee, Finance and Budget Committees, Legislation/Public Policy Committee, Governance Committee and the Isabella Candee Foundation.



Add a new C.9. as follows:

To Read: C.9. Conduct orientation workshop for incoming committees with the Director Elect of Junior Clubs.

Add a new C.10. as follows:

To Read: C.10. Mentor and coach Committee Chairmen and/ or Committee Members for leadership development and encourage participation in LEADS.

Add a new C.11. as follows:

To Read: C.11. Attend GFWC Orientation prior to the start of her administration.

Add a new C.12. as follows:

To Read: C.12. Perform such other duties as may be assigned by the President and/or the Director of Junior Clubs.

Rationale: Consolidating and updating roles of each Executive Officer

ARTICLE V—Section 5. DUTIES OF OFFICERS, Subsection D. **Vice Presidents**

D. Inserting a new D:

To Read:

- D. Director Elect of Junior Clubs The duties of the Director Elect of Junior Clubs shall be to:
 - 1. Perform the duties of the Director of Junior Clubs in her absence or at her request.
 - 2. Perform the duties of the President in the absence of the President, the Director of Junior Clubs and the President
 - 3. Serve as Reporting Committee Chairman.
 - 4. Serve as Chairman of sub-committee for Junior Standing Rules, Policy & Procedures.

As recommended by the Bylaws Committee

Chairman Jeanette T. Wells, Central Region Vice President Cathy Marsoun, District President Susan Haa, President Elect LeeAnn Conlon, Director of Junior Clubs Patti Kuchar, Parliamentarian Diane Addante and President Teresa Sanford-Shipplett, ex-officio

Note: These proposed amendments were printed in the 2020 Convention Issue of *The Clubwoman* magazine; however, they were not voted on due to the cancellation of the 2020 Annual Convention.

ARTICLE IV—DUES AND FINANCE, Section 2. ANNUAL DUES, B.

In the first sentence, strike "five dollars (\$5.00)" and insert "ten dollars (\$10.00)." Strike the second sentence

To Read: B. Each member of a club shall pay annual GFWC Illinois dues of ten dollars (\$10.00). The GFWC Illinois dues structure shall be reviewed every four years beginning with the year 2024.

Rationale: Recommendation by the Finance Committee. At the 2017 GFWC Illinois Convention, delegates passed an increase in dues from \$5.00 to \$10.00, by \$1.00/year. Increasing to the \$10.00 in one year will lessen confusion from members.

Clarification: This would mean in 2021 dues would be \$10.00 instead of \$9.00 AND then this wouldn't be reviewed again until 2024.

ARTICLE IV—DUES AND FINANCE, Section 5. **AUDITING AND BONDING**

Strike A. and insert a new A.

To Read: A. At the close of the fiscal year, a Review of the books shall be made of the first year of an administration and a full Audit shall be made at the close of an administration. Both will include the records of the Treasurer, Headquarters Executive Secretary, Meetings and Convention Treasurer, Fund Raising Chairman, and Treasurer of the Junior Organization.

Rationale: It is not necessary to have a full audit performed every year as a review will provide the necessary documentation to file the proper tax documents. Additionally, a C.P.A. is not necessary if the person or business performing the review or audit has the correct credentials. Both can save GFWC Illinois money.

ARTICLE V—OFFICERS, Section 6. EXECUTIVE COMMITTEE, B. Duties, 5.

Insert "or a qualified third party" after "auditor:

To Read: 5. Retain an auditor or a qualified third party by spring of each year, subject to approval of the Board of Directors at the Spring Meeting.

Rationale: Allows for more flexibility and could save GFWC Illinois money.

ARTICLE VI—BOARD OF DIRECTORS, Section 5. DUTIES, I., 4.

Strike "annual" and insert "review or".

To Read: I. 4. Approve the Review or Audit.

Rationale: Consistency with the previous bylaw amendment.

Note: These proposed amendments are for future consideration as recommended by the 2020-2022 Bylaws Committee.

Article IV—DUES AND FINANCE, Section 3. FUNDS, **Subsection A., Item 2.**

In the last sentence strike "paid" and insert "transferred" and delete "General" and insert "Working Cash".

To Read: 2. Isabella Candee Foundation – The Foundation principal and additional contributions received for the Isabella Candee Foundation shall be invested to help secure the future of GFWC Illinois. The principal of this Foundation shall remain in perpetuity. Income from these invested funds shall be transferred to the GFWC Illinois Working Cash fund.

Rationale: To reflect current practices.

Article IV—DUES AND FINANCE, Section 3. FUNDS, Subsection A., Item 3.

In the first sentence insert "Consist of the Scholarship Fund," after "Funds" and before "GFWC" and strike "Very Special Arts, Pennies For Art and the Scholarship Fund" after "Projects" at the end.

To Read: 3. Special Funds - Consist of the Scholarship Fund, GFWC and GFWC Illinois Monetary Projects. Expenditures from Special Funds shall be limited to the purpose of the funds. Funds may be diverted to other projects by a two-thirds vote of the Board of Directors, previous notice having been given.

Rationale: No other monetary projects are listed in the bylaws.



ARTICLE V—OFFICERS, Section 5. DUTIES OF OFFICERS, Subsection E. Secretary

E.1. Strike "Keep" and insert "Record" at the beginning of the sentence; insert "and submit for review and approval as per the Policy/Procedure manual." at the end of the sentence.

To Read: E. 1. Record minutes of the meetings of GFWC Illinois, its Board of Directors and Executive Committee and submit for review and approval as per the Policy/Procedure manual.

E.2. Strike in its entirety.

E.3. Strike in its entirety.

E.4. Becomes the new E.2.

E.5. Becomes the new E.3.

E.6. Becomes the new E.4.

Rationale: To align with current practice and to clarify.

ARTICLE V—OFFICERS, Section 5. DUTIES OF OFFICERS, Subsection F. Treasurer

F.2. Strike "on a monthly basis" and insert "at each meeting" at the end of the sentence.

To Read: F.2. Monitor the budget and submit a written accounting to the members of the Executive Committee at each meeting.

F.3. Strike "monthly" after "written" and before "financial".

To Read: F.3. Study and review the financial accounts with the Headquarters Executive Secretary prior to each Board of Directors Meeting, submitting a written financial report to the members of the Executive Committee and the Board of Directors at each meeting.

F.5. Strike in its entirety and replace as follows:

To Read: F.5. Prepare and communicate dues collection guidelines to clubs and submit dues to GFWC.

F.6. Strike in its entirety and replace as follows:

To Read: F.6. Oversee and execute actions required to fulfill information requests for financial audit or review. Participate in the full financial audit or review held in the Fall each year of the administration. As Immediate Past Treasurer participate in the full financial audit in the Fall immediately following her term.

Rationale: To align with current practice and to clarify.

ARTICLE V—OFFICERS, Section 6. EXECUTIVE COMMITTEE Subsection B. Item 3.

3. Strike in its entirety.

Rationale: To align with current practice of the Executive Committee.

ARTICLE V—OFFICERS, Section 6. EXECUTIVE COMMITTEE Subsection B. Item 7.

7. Strike "and an Assistant Secretary as needed" at the end of the sentence.

To Read: 7. Approve the employment of a Headquarters Executive Secretary.

Rationale: To align with current practice.

ARTICLE V—OFFICERS, Section 6. EXECUTIVE COMMITTEE Subsection B. Item 11.
