

mindedness, valor, diligence, integrity, kindness, humility, and optimism. **Thank you for bee-ing adventurous.**


This administration was definitely a "WE" not a "ME" one. Our team was one that was willing to take risks, try new ideas and explore new experiences for our members. Going on an

The David Davis Mansion in Bloomington at 1000 Monroe Street is the beautifully restored home of former Supreme Court and U.S. Senator from Illinois David Davis and his wife Sarah. The home was completed in 1872 and had what was then the most amazing modern conveniences of that time. This three-story house design is Italianate and Second Empire. The house is yellow brick with 36 rooms, surrounded by over 4 acres of lawn and beautifully restored gardens with a number of outbuildings. After arriving at the house called "Clover Lawn" by the Davis's, we will view a short video and tour the house and gardens. Please be aware that a number of steps are involved, even getting into the house.

After viewing the mansion, we will go to Biaggi's Ristorante Italiano for lunch on your own and then back to the DoubleTree in plenty of time for the Board Meeting... or to shop at the Convention vendors!



FEBRUARY BOARD MEETING PROJECT | BOOKS FOR CAYCE



A New Book "Case" for Cayce, Kentucky

ayce is a small town in Kentucky that was one of the first hit when the devastating December 10th tornado came through. There were 60 homes in this town...37 were destroyed! People of various ages live there, but many are retired. The pastor of a local Baptist church is trying to open a community reading room and put out the word that he is in need of books. Here is where GFWC Illinois saw an opportunity to help.

A book collection was taken at our February Board meeting in Bloomington, Illinois, with Board members donating many boxes of books. Board members who could not attend the meeting also donated boxes of books. When all was said and done, we estimate over 600 books were collected for the Cayce community reading room!

But how would we get all of these boxes of books to Kentucky? As luck would have it, GFWC Illinois President Teresa Sanford-Shipplett has a cousin who lives 15 miles from Cayce and was willing to help. A plan was made and the boxes of books were loaded into a pickup truck for the drive to Kentucky, where they were safely delivered to the pastor at the Baptist church with the help of Teresa's Kentucky cousin.

As a side note, John Jones aka Casey Jones (of railroad engineer fame) was from Cayce. This folk hero's "Midnight Run" was made famous in "The Ballad of Casey Jones" written in 1909 and most notably sung by Johnny Cash – one of over 40 versions produced!

Rationale: In this position a background in finance and accounting would be beneficial and to expand the pool of candidates.

WHEREAS, Research has strongly indicated that underage users of ENDS are more likely to move onto the use of combustible cigarettes; and

WHEREAS, It has been found that among youth and young adult users, less than half know ENDS frequently contain nicotine, which causes addiction; therefore

RESOLVED, That GFWC Illinois Federation of Women's Clubs supports actions by the FDA and local, county, state and federal lawmakers (evidenced by legislation); and

RESOLVED, That GFWC Illinois Federation of Women's Clubs supports:

- 1. Advocating for the enactment of laws at the local, state and federal levels regulating ENDS
- 2. Advocating for initiatives preventing access to flavored tobacco products, curbing marketing aimed at youth, and educating youth about the dangers and risks of vaping; and further

RESOLVED, That GFWC Illinois Federation of Women's Clubs urges its members to promote public awareness of the hazards and risks associated with youth vaping by use of ENDS.

PROPOSED NEW RESOLUTIONS

CIVIC ENGAGEMENT & OUTREACH COMMUNITY SERVICE PROGRAM

SAFE DRIVING PRACTICES

WHEREAS, Many people in the United States are injured or killed by motor vehicle accidents caused by human error, including inattentive driving and inexperience; and

WHEREAS, Motor vehicle accidents are the leading cause of teen death in the United States; and

WHEREAS, Various distractions take a driver's attention away from operating a motor vehicle; therefore

RESOLVED, That the GFWC Illinois Federation of Women's Clubs urges its member clubs to support extensive driving practice and quality driver education; and

RESOLVED, That the GFWC Illinois Federation of Women's Clubs urges its member clubs to sponsor defensive driving courses for the benefit of their communities and encourages its individual members to participate in such courses; and further

RESOLVED, That the GFWC Illinois Federation of Women's Clubs supports:

- Efforts to eliminate distractions while driving and the injury and death that may result, including industry-led engineering solutions to reduce crashes;
- Enforcing existing laws and new legislation prohibiting distracted driving;
- Legislation creating increased penalties for distracted driving.

Rationale: To update and broaden into a more effective resolution.

Proposed to be rescinded pending adoption of New Resolution "Safe Driving Practices" above:

SAFE DRIVING PRACTICES (Adopted 2003 – Revised 2011)

WHEREAS, Too many people in the United States are killed or injured by motor vehicle accidents caused by human error and inattentive driving; and

WHEREAS, Defensive driving courses have been shown to assist drivers in reducing both accidents and traffic law violations appreciably; and

WHEREAS, There has been an alarming increase in motor vehicle crashes caused by inattentive drivers performing personal grooming activities, reading, eating, smoking, tuning the radio, and talking on cellular phones and texting; therefore

RESOLVED, That the GFWC Illinois Federation of Women's Clubs urges its members to sponsor defensive driving courses for the benefit of their communities, and urges its individual members to participate in such courses; and further

RESOLVED, That the GFWC Illinois Federation of Women's Clubs and its members support laws:

- Prohibiting the use of hand-held cellular phones and texting for non-emergency calls while driving; and
- 2. Enforcing existing laws and new legislation prohibiting inattentive driving.

ENVIRONMENT COMMUNITY SERVICE PROGRAM

RENEWABLE ENERGY

WHEREAS, Global security and economic well-being demands a balanced use of energy resources; and

WHEREAS, Renewable energy resources reduce the dependence of the United States on foreign energy, are environmentally sensitive, create economic opportunities for America's farmers and rural communities, and are necessary in meeting the nation's future energy need; therefore

RESOLVED, That the Illinois General Federation of Women's Clubs urges its members to promote and conduct conservation programs which relate to reducing the level of energy consumption; and

RESOLVED, That the Illinois General Federation of Women's Clubs urges governments, private industry and consumers to:

- Focus public attention on the need for adequate energy and the need for coordinated energy policies;
- Encourage balance between the interests of proper management of resources, adequate water supplies and protection of wildlife, with the interests of energy production; and

RESOLVED, That the Illinois General Federation of Women's Clubs urges governments and private industry to research, explore and develop efficient and effective energy sources; and further

RESOLVED, That the Illinois General Federation of Women's Clubs supports legislation to fund and expand renewable energy resources, including a higher national renewable energy standard and decreasing consumption of all non-renewable fuels

Rationale: To be compliant with GFWC, reflect current times, support legislative action, and speak to the US dependence on foreign energy.

Proposed to be rescinded pending adoption of New Resolution "Renewable Energy" above:

ENERGY CONSERVATION (Adopted 1977 – Revised 2011)

WHEREAS, The energy situation is of national and international concern and its solution affects the peace of the world; and

WHEREAS, The United States continues to face issues surrounding adequate supplies and high costs of energy which intrude upon our daily lives, growth and economic development; and

WHEREAS, The conservation of energy and the reduction of energy demands are vital to both our energy and environmental goals; and

WHEREAS, The Illinois General Federation of Women's Clubs urges government and private industry to: focus public attention on the need for adequate energy and the need for coordinated energy policies; research, explore and develop efficient and effective energy sources; and encourage balance between the interests of proper management of resources, adequate water supplies and protection of wildlife with the interest of energy production; therefore

RESOLVED, GFWC Illinois Federation of Women's Clubs urges its members to devise, promote and conduct programs which relate to individual, family, and community consumption and conservation of energy.

HEALTH & WELLNESS COMMUNITY SERVICE PROGRAM

CHILD CARE

WHEREAS, A safe, educational and nurturing environment is essential to the well-being and development of children; and

WHEREAS, The Bureau of Labor Statistics reports that the majority of families with children under the age of 17 have the single parent or both parents in the paid work force; and

WHEREAS, The high cost and lack of available quality care contributes to young children being placed in mediocre child care or being left unattended; and

WHEREAS, Unexplained absences of young children may be attributed to abductions, serious injury, or death; therefore

RESOLVED, That the Illinois General Federation of Women's Clubs supports legislation and private initiatives to make quality child care affordable and accessible to all; and

RESOLVED, That the Illinois General Federation of Women's Clubs supports legislation regulating and enforcing health and safety standards of child care facilities; and further

RESOLVED, That the Illinois General Federation of Women's Clubs urges its members to:

- Support increasing the federal child care tax credit for working parents;
- Support measures requiring early childhood training and increasing the wages of child care providers;
- Encourage self-supporting, independent after-school programs in specified areas of school facilities;
- Encourage the enactment of legislation mandating that all child care facilities establish a two-way notification system when a child scheduled to be in attendance is absent from the facility.

Rationale: Update and broaden into a more effective resolution, compliance with GFWC.

Proposed to be rescinded pending adoption of New Resolution "Child Care" above:

QUALITY CHILD CARE (Adopted 2003 – Revised 2011) Note: This resolution was formerly under the heading of Public Issues.

WHEREAS, A safe, educational and nurturing environment is essential to the well-being and development of children; and

WHEREAS, Many parents and custodians of young children must be employed outside the home to ensure the economic survival of their families; and

WHEREAS, The high cost and scarcity of quality child care contributes to young children being placed in mediocre child care or being left unattended; therefore

RESOLVED, That GFWC Illinois Federation of Women's Clubs urges support of:

Legislation and private initiatives to make quality child care affordable and accessible to all; and

Legislation regulating and enforcing health and safety standards of child care facilities; and further.

RESOLVED, That GFWC Illinois Federation of Women's Clubs urges members to:

- Evaluate the availability of child care facilities in their communities, and take appropriate action;
- Support increasing the federal child care tax credit for working parents; and
- Support measures requiring early childhood training 3. and increased wages for child care providers.

TOLERANCE AND DIVERSITY

WHEREAS, The unchecked growth of prejudice, incitement to violence, racism, stereotyping, terrorism, and intolerance endangers members of society, leads to violation of the rights of others, and destruction of property; therefore

RESOLVED, That the Illinois General Federation of Women's Clubs urges its members to:

- Promote community awareness about the unique diversity of other cultures;
- Foster tolerance, acceptance, and benefits of diversity;
- Support the United Nations Educational, Scientific and Cultural Organization (UNESCO) International Day for Tolerance.

Rationale: To be in compliance with GFWC.
